



## 'OSV@Vivo' Photo Contest Official Rules

### Terms

- I. The 'OSV@Vivo' Event Photo Contest begins April 21, 2016 at 6:00p.m. ALL ENTRIES HAVE TO BE SUBMITTED BY MAY 30, 2016 AT 23:59P.M. Late submissions will not be entertained. By submitting photo for this Contest, the Participant will be deemed as having accepted and agreed to be bound by the rules and regulations of the Contest.
- II. The Singapore Shipping Association (SSA) (the "Organiser") reserves the rights to adjust any deadline(s) as the result of causes beyond its immediate control.

### Rules & Regulations

#### Who may participate

This Contest is open to all Singapore Citizens, Permanent Residents and Foreigners residing in Singapore.

- I. Participants who are below 18 years of age shall submit proof of parental or guardian consent for their participation in this contest, if required by the Organiser;
- II. Working Group Members of the "OSV@Vivo" Event are not eligible to participate in this contest.



## How to participate

Each entry consists of an official entry form, whereby up to 5 photographs may be submitted per form. To enter the contest, please visit [www.osvatvivo.org](http://www.osvatvivo.org), complete the [form](#) with the required information, including your name, address, contact details, email address and photo caption within 100 words. The official entry form and photograph(s) are to be submitted to: [enquiry@osvatvivo.com.sg](mailto:enquiry@osvatvivo.com.sg), alternatively Participants may also send us the file via [WeTransfer](#) to the above email stated.

Each entry must comply with the requirements as stated below:

- I. Photographs submitted must be in digital form. Only online entries will be eligible. No print or film submissions will be accepted for entry in this Contest. Each photo must not exceed the size of 10MB and at least 1,600 pixels wide for horizontal image or 1,600 pixels tall for a vertical image and must be in JPEG, or .jpg, or .gif format.
- II. Photographs taken must be related to the “OSV@Vivo” Event, happening from April 21, 2016 to April 23, 2016 at Vivo City. Entries must be taken only of areas that are accessible to the general public, and Participants have to abide to the Safety Advisory on board the ships where they take the photographs.
- III. The photograph must not contain any prohibitive, objectionable or inappropriate content. The Organiser reserves the rights to refuse any photographs that contain any inappropriate content.
- IV. Digital manipulation is acceptable, however, it is advisable that digital manipulation should be kept to the minimum, so as to prevent misinterpretation of the reality of the photographs. High dynamic range images (HDR) and stitched panoramas are acceptable.
- V. If Participants choose to submit a photograph that includes individual, other than yourself in the photograph, you are responsible for obtaining the necessary permissions from the individuals depicted before submission.
- VI. The photograph, in its entity, must be a single work of original material taken by the Participant. By entering the Contest, the Participant acknowledges, and warrants that the submitted photograph is an original work and does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.
- VII. The caption must be complete and accurate, sufficient to convey the circumstances in which the photograph was taken. Disguising and misrepresenting the origin of your content could lead to disqualification.
- VIII. Watermarks are unacceptable. Photographs with watermarks will be disqualified.

## Judging

- I. Entries will be judged based on the following criteria:
  - Relevancy: How well does the photo relates to the Event?
  - Composition: Are the items of interest placed well in the photo? Are there any distracting elements?
  - Creativity: Is the subject matter pictured in a unique way? Does the photo demonstrates originality?
  - Technical Quality: Is the photo in focus? Is the lighting in balance?



- **Overall Impression:** Is the photo able to grab the viewer's attention and hold it? What is the WOW factor?
- II. Should the entries fail to meet the requirements stated as above, the Organiser reserves the right not to award the prizes.
- III. All decisions are final and no correspondence relating to the selection process and decision will be entertained.

#### Contest Prizes

- I. Top 3 Winners will be awarded with SGD\$1,000, SGD\$500 & SGD\$300, respectively.

#### Notification of Winner

- I. Each eligible Participant will stand a chance to win.
- II. Winners will be notified via email and the winning entries will be posted on the "OSV@Vivo" website and Facebook page.
- III. Winners will be invited to the SSA's Cocktail, to receive their prizes, which will be held on June 30, 2016, in Singapore.
- IV. The Organiser reserves the right to change, add or substitute the prizes. Prizes that are left unclaimed after 30 days will be forfeited and disposed by the Organiser as it deems fit.

#### Copyright

##### The Participant

- I. The Participant warrants that he/she is the sole owner of all intellectual property right (including copyright) and other proprietary rights to the photographs and content of the caption, and any other creative materials submitted for this Contest (collectively, the "materials"), and that he/she has not licensed or assigned any intellectual property rights in the materials to any other person.
- II. The Participant retains full copyright of the materials entered for the Contest.
- III. The Participant grants the Organiser a complimentary, non-exclusive and transferable right to use, reproduce, edit or distribute any materials submitted for the Contest in any media format and any media channels as deemed fit by the Organiser, for the purposes of promoting the Contest, publicity and write-ups of "OSV@Vivo" or the causes that the Organiser stands for such as:
  - Singapore Shipping and Maritime Industry
  - Singapore Maritime Heritage/History
- IV. Entries that do not fulfil the above criteria will be deemed as ineligible and will be disqualified.

##### The Organiser

- I. The Organiser reserves the right to use, reproduce, edit and distribute any materials submitted for this Contest for publication and/or display in any media format and any media channels without obtaining further prior permission and payment of any fees to the Participant. The materials may be used for the following purposes:



- Operating, administering and promoting the competition, before and after the competition has ended;
  - Displaying the Participant's materials on the competition website and/or the Organiser's websites;
  - Issuing a media release or making media pitches with materials regarding the winning entries;
  - Usage of the Participant's materials during the Organiser's events, exhibitions and in publications both printed and online, for purposes which are non-profit in nature, such as for promotion for Maritime-related awareness in Singapore.
- II. Where any materials of a Participant is published or displayed by the Organiser, the Participant will be credited.

#### Liability

- I. The Organiser will exercise care in handling the entries and materials submitted. However, they will not be liable for any loss or damages to the entries or materials howsoever caused.
- II. The Participant shall assume all risks in respect of loss, injury, damage or liability which may arise as a result of or in connection to the Participant's participation in the competition, and shall not hold the Organiser responsible in respect thereof except for liability which cannot be excluded by law.
- III. The Participant shall defend, fully indemnify and hold the Organiser and its employees and agents harmless from and against:
- All liabilities, damages, losses, costs (including legal costs on a full indemnity basis) and expenses arising from any claims, demands, actions, proceedings, judgement or execution which the Organiser, its employees or agents may suffer or incur from or in connection to the Participant's participation in the competition; and
  - Any claims, demands, actions, proceedings, judgement, or execution arising from infringement or alleged infringement of any copyright or other intellectual property right or violation of confidentiality in the materials produced, reproduced or submitted for the competition.
