TRANSFER PRICING

Transfer pricing is currently one of the hottest topics of international taxation. Transfer pricing has become the key tax compliance focus of tax authorities worldwide. The Singapore tax authority (“IRAS”) is no exception. In their recent transfer pricing guidelines, the IRAS has required businesses to prepare contemporaneous transfer pricing documentation for their related party transactions. With this move, corporates should expect the IRAS to significantly step up its enforcement of transfer pricing compliance.

This talk will focus on Transfer Pricing and why it matters to shipping companies in Singapore.
